

PHIN Awards

We will be celebrating some of the initiatives, projects and people that are helping to improve the healthcare sector and presenting four new PHIN awards.

The categories and shortlist of candidates are:

<u>Consultant contribution</u>: Consultant practice or consultant rep who makes biggest contribution to PHIN's work.

- Ram Moorthy has represented the views of ENT and thoracic surgeons very effectively. He has been key in reviewing procedure groups in this specialty, has helped our engagement with BAETS. Following this engagement, we will shortly show links to the BAETS registry so that patients can access information.
- Colin Esler has provided PHIN with valuable feedback across a range of issues. He helps in providing a 'consultant perspective' as we develop systems and processes and offers practical suggestions for improvements.
- David Houlihan-Burne has been a supporter of PHIN's objectives since its inception. He is passionate about the provision of quality of data to patients and scrutinising his PHIN data, thoroughly. He has been a sounding board for PHIN for several years across a range of issues.

<u>Promotion of PHIN:</u> Actions to raise awareness of PHIN and encourage patients to make more informed healthcare choices.

- Sue Harvey (Ramsay healthcare) for working relentlessly behind the scenes travelling to different sites to educate, support and enhance current work on PROMs.

PHIN Awards

<u>Innovation with a patient focus</u>: Use of data, especially PROMs, with significant impact on patient outcomes and/or experience.

- HCA Healthcare UK for innovation and implementation in the use of robot-assisted surgery.
- Leeds Teaching Hospital improving outcomes through work to develop its theatre packs.
- Health Screening Solutions Ltd Providing capsule endoscopy service to allow patient investigation to take place at home.

<u>Best use of PHIN data</u>: Highlight how you have used PHIN data to make a difference to your operations and/or processes.

- Ramsay Woodland Hospital for the implementation of a process to review patient outcomes feedback in near to real time, including an action register to follow up with patients with worse outcomes.
- Nuffield Health for using PHIN data for Adverse Events and PROMs to create funnel plots and undertake internal outlier analysis.
- Aviva for using PHIN data in an approach focused very much around quality improvement and clinical safety & governance, and engaging with hospitals and consultants on using this data to support improved patient outcomes.

Speakers



Dr Avi Mehra

Dr Avi Mehra is an Associate Partner for Healthcare & Life Sciences and Clinical Safety Officer at IBM, where he is responsible for supporting healthcare clients to improve patient care through leveraging IBM's technology capabilities and consulting expertise, and leading clinical safety assurance for IBM's digital health solutions. He also advises new health tech companies and is involved in coaching and mentoring. Before IBM, he led digital health projects at Bupa and worked in the NHS as a doctor. He studied medicine and management at Imperial College.



Dr Chris Smith-Brown is a doctor and health informatics specialist, who has worked in both private and public healthcare sectors. He is PHIN's Clinical Advisor. He was previously a management consultant for Carnall Farrar, a leading healthcare consultancy.

Dan Jones

Dan Jones is the head of Government Affairs for Stryker in the UK and Ireland, with nearly 20 years in politics and 15 in the medical device industry. He began his career in politics supporting a Labour MP and later worked in Parliament.

After joining ABHI, he advanced to Director of Communications, managing public affairs and communications. He then moved to Brussels, leading a medical device practice at a consultancy, before returning to the UK with Healthcomms Consulting, focusing on advocacy and market access for medical devices. Since 2021, at Stryker, he's been managing relationships with government and NHS leaders to enhance market access for medical devices.



David Houlihan-Burne

Mr David Houlihan-Burne specialises in all aspects of knee surgery. He pioneered the Rapid Recovery Programme in the UK, the patient-centred approach to hip and knee replacement surgery and is one of Europe's leading surgeons in the use of robotic knee replacement.

His other surgical interests include knee preservation surgery, using techniques such as cartilage and osteotomy surgery for younger patients with arthritis.



Since joining PHIN as CEO in September 2022, Dr Ian Gargan has spearheaded significant changes, aligning the organisation with the mission to empower patients with data for informed healthcare choices. His leadership focuses on enhancing transparency and efficiency in private healthcare, leveraging his medical background and data-driven approach.

Dr Rachael Kent

Dr Rachael Kent is a prominent researcher and lecturer at King's College London, focusing on the effects of digital technology on health. She hosts the podcast "Digital Health Diagnosed," which delves into how technology influences well-being, based on solid evidence. As the founder of Dr Digital Health, she advises major clients like the NHS and UK Government on tech-related health issues.

Additionally, Dr Kent is notably the first female class representative in the UK to lead a legal action against Apple, seeking £1.5bn for overcharging on app purchases. Her insights are frequently featured in various media outlets, and she authored "The Digital Health Self" in 2023, exploring wellness in the digital age.



Richard Gregory

Richard spent most of his career in the International Insurance business with AGF Assurances and then Allianz, spending many years working in France and Japan. Since returning to the UK in 2005 he has spent his time working in the UK private healthcare market for Nuffield Health and Circle Health, holding various senior commercial, sales and business development roles.

He has a specific expertise in consumer healthcare (self-pay), speaking at many conferences and regularly contributing in the industry press. Through his consulting business, Jaspers Consulting, Richard now works extensively with Chrysalis Finance, providing them with strategic support and senior networking.



Richard Wells

Richard Wells, with nearly 30 years of experience in the NHS, now serves as the Director of Tech, Product, and Informatics, leading teams that specialise in gathering and analysing data from private healthcare facilities across the UK. Sam is involved with various healthtech organisations, focusing on ecosystem development, and has led significant projects in digital transformation, service redesign, and public health programs. His expertise extends into healthtech regulation, public health, and behavior change.



Dr Shruti Patel is a medical doctor dual certified in paediatrics and public health. She has a wide range of healthcare experience, having worked clinically in both the UK and Australia and subsequently in a range of delivery and strategic leadership roles. Her work has focused on leading transformation of services and improving quality, with a focus on optimising use of data and digital technologies.
